4th ENCLE Conference 27th and 28th October 2016 Faculty of Law, University of Valencia Valencia (Spain)

"Clinical Legal Education and Access to Justice for all: from asylum seekers to excluded communities"

The European Network for Clinical Legal Education (ENCLE) will host its annual conference at the Faculty of Law, University of Valencia, Valencia (Spain). The conference aims to bring clinicians together from across Europe to discuss all aspects of teaching and learning, learn from each other and share best practices on how to improve the access to justice to, in particular, vulnerable persons, through clinical legal education.

Given the on-going influx of refugees in Europe and the fact, that more and more law clinics are focusing their work on the support to refugees and asylum seekers, ENCLE is particularly encouraging papers dealing with CLE and access to justice for refugees and asylum seekers.

The conference will include a range of sessions including workshops, paper presentations, plenaries and panel discussions. The sessions will be designed to encourage participation, stimulate discussion, share best practices and enhance the clinical movement across Europe.

The conference will be organized around the following themes:

- Clinics and refugees how are refugees transforming CLE in Europe and how clinics react to influx of refugees?
- Improving access to justice through legal clinics
- Legal clinics and marginalized, excluded or vulnerable clients (communities)
- The role of clinics in Higher Education
- Teaching methodology
- Legal professions and Clinical legal education
- Clinical impact

Venue:

The 4th ENCLE Conference will be hosted by the Law Faculty of the University of Valencia (*Facultat de dret, Universitat de València*) which is one of the oldest universities in Spain, and is regarded as one of Spain's leading academic institutions. The University was founded in 1499, and currently has around 55,000 students.

Fee:

The conference fee is **100 Euro**. Please note that the registration fee covers **all costs related to the conference (including the conference dinner)**, but will NOT include costs for accommodation or travel.

Registration process for the ENCLE conference:

If you are interested in participating, please register for the conference in the following way:

- 1) Send an email to 4th.encle.conference@gmail.com by indicating Name, Surname, Organisation or Affiliation, Professional title or Position and whether you have submitted a session/paper proposal for the ENCLE conference.
- 2) By transferring the registration fee of 100 Euro to the ENCLE bank account (Bank: Fio banka, a.s. Please indicate your name in message for recipient.
- 3) *Fee waiver:* Please note that the registration fee covers all costs related to the conference, but will NOT include costs for accommodation or travel. In addition, please note that if you apply for a fee waiver you **MUST** provide reasons on why you cannot afford to pay the conference fee. Please keep in mind that ENCLE tries to put all efforts possible in order to provide those, who are not able to attend our conferences otherwise, with financial support. We therefore would ask you to apply to the fee waiver **ONLY** in such a situation.



- 4) *Travel and/or accommodation grant:* In case, you are applying for travel and/or accommodation grant, please include the following information in your registration: the means of travel (including dates and times) and approximate price, the dates for which you need accommodation, and the reasons, why you cannot cover these costs from other sources and how will your participation in the ENCLE conference promote clinical legal education in your institution or country.
- 5) The deadline for the registration is the <u>30th September 2016</u>. However, if you apply for fee waiver or travel grant, the deadline is <u>31st August 2016</u>, and you will be notified by <u>18th September 2016</u> about the outcome of the grant/waivers allocation. Please note that your registration process is only successful when:
 - a. the registration fee has been effectively transferred within this timeframe to the ENCLE account, or
 - b. the fee waiver request has been accepted.
